Craig also noted that under the new constitution there is no longer a President, instead, and at the next Board meeting, there would be a vote to elect a Chair for the next twelve months.

After all postal votes were counted, Craig Scott presented Peter Barnes with Life Membership of Little Athletics NSW for his extensive contribution to the organisation over many years.

Peter has been involved with Little Athletics since 1983/84. He was elected onto the Board of Directors of Little Athletics NSW in 2005 as Officials Director. Peter has achieved his Level 2 in Administration under the Australian Athletics Officials Education Scheme and recently completed two weeks at the Gold Coast, volunteering at the 2018 Commonwealth Games.

Peter thanked Craig for his kind words, the voting delegates for supporting his nomination and the directors for their support and friendship over the years. Peter noted how many fantastic friendships he has made as a result of his involvement with little Athletics NSW.
