REPORT of the 50th ANNUAL GENERAL MEETING of LITTLE ATHLETICS NSW LTD Held Via Teleconference, 18 July 2020

The meeting opened at 4.32pm. The Little Athletics NSW Board of Management resolved that the 2020 election of Directors would be conducted as an electronic ballot only. Voting for the election of Directors closed at midday on Thursday, 16 July 2020.

viii) PRESENTATION OF 2019/2020 ANNUAL REPORT & FINANCIAL STATEMENTS

The 2019/2020 Annual Report and Financial Statements were available for download from the Little Athletics NSW website.

Members were given the opportunity to electronically lodge questions relating to the 2019/2020 Annual Report and Financial Statements prior to the Annual General Meeting.

No questions were lodged in relation to the 2019/2020 Annual Report.

The outgoing Finance and Audit Committee Chair, Glen Taylor, summarised the 2019/2020 Financial Statements.

- This was the first full operating year as a Company Limited by Guarantee
- Little Athletics NSW saw a small surplus (\$3,729.00) following last year's surplus (\$269,013.00).
- There was little movement in the balance sheet which remains steady at \$4,700,000.00 total assets. This total consists mainly of cash holdings and the building (Office) asset
- Little Athletics NSW is in a very solid financial position to withstand the challenges of the season ahead
- Little Athletics NSW will be waiving affiliation fees for 2020/2021 and will not increase registration fees
- All centres will receive 'Return to Sport Packs' which will include signage, sanitiser and disinfectant wipes

• There will be additional staff diverted to centres increasing investment in centres

Independent audit services were provided by KPMG.

Glen thanked the staff, Ken Carter (Company accountant), KPMG (Auditors), the Board and Kerry O'Keefe (outgoing CEO) for their efforts over the past season.

The following question was received from Terrigal Little Athletics Centre.

"Why does Little Athletics NSW carry such a huge surplus of funds rather than put the accumulated monies back into the sport in terms of better technology (rather than the archaic systems and paper processes centres have to deal with), increased staff (rather than relying on volunteers), more accessible and relevant resources for clubs, reduced fees, reduced cost for education of officials, etc. It is quite incredible to see the organisation sitting on nearly 3 million dollars (if I am reading the financials correctly?) when clubs are struggling to maintain members and safely/efficiently run competition days/nights in the modern era."

Glen replied that the Little Athletics NSW was in a strong financial position which had allowed us to combat the current emergency better than many other sports. Little Athletics NSW has been able to retain all staff, divert funds back to centres and meet all challenges encountered last season from fire, floods and poor air quality through to COVID-19. Glen thanked Terrigal Little Athletics Centre for their question and said he would send them a separate, more detailed email response.

Craig also paid tribute to Di Levy, the longest serving staff member of Little Athletics NSW. Di has been a staff member for thirty four (34) years and will be retiring in October. She has made an enormous contribution to Little Athletics in NSW over an extended period. It was a shame that the disappointing end to the season robbed Di of the opportunity to farewell numerous friends and colleagues.

The Chairman thanked delegates, zone coordinators, life members, directors and staff for their attendance.

There being no further business the Chairman declared the fiftieth (50th) Little Athletics NSW Annual General Meeting closed at 5.01pm.
